Policy 526 is a new policy. Content is coming from the other 3 policies. This policy clarifies student options to submit petitions for record adjustments, refund requests, and clarifies what academic renewal can mean for a student.

Policy 523 – We are looking to change course repeats. Instead of using the most recent attempt, we will take the highest grade. We are also considering the elimination of U and W grades. They seem to cause more pain than they are worth.

Policy 522 – This policy allows students to earn multiple associate degrees. Currently, students can earn multiple Bachelor's degrees but not Associate degrees. We are adding additional transfer information. We are not changing anything that we are doing but we are clarifying and cementing it in policy.

Policy 503 – Eliminating the requirement for department chairs to approve withdrawals.

Graduate Program Policy Bundle - Kyle Hicken and Jim Bailey

Policy 510 -Moving the continuation requirements from the admission policy to the Policy 524. Also addressing TOEFL and IELTS English proficiency exemptions. If students come from specific countries, they will be exempt if those countries are primarily English speaking countries. We added information regarding joint and combined Master's programs. We added information about 5000 and 6000 level courses to better align them with state policy.

Policy 524- Added the continuation requirements from Policy 510. Addresses students wanting to get a second Master's degrees. Addresses joint Master's degree where students can take 2 Master's degrees at the same time and how credits for both degrees can be used for the other degree and the limitations on that. Also address combined Master's degrees where a program can set up so a student can finish their Bachelor's degree, their last 30 credits as an undergrad while they are in the graduate program allowing them to receive both the Bachelor's degree and the Master's degree at the same time. Added some information regarding graduate credit for prior learning.
