- **Legislative Updates:** Provided updates on the legislative activities, focusing on the reallocation decision and its impact on the University. Mentioned the challenges of implementing changes over the summer and the need for Deans to identify areas for trimming back.
 - Reallocation Decision: the bill is progressing through various stages with additions and removals. Emphasized the importance of understanding the final requirements.
 - Faculty Engagement: encouraged Deans to look at workloads, course scheduling, and adjunct expenditures to protect full-time positions while meeting legislative requirements.
 Stressed the importance of faculty engagement in the process.
 - Legislative Engagement: encouraged faculty to engage in the legislative process as private citizens, emphasizing the importance of participating in public matters while ensuring they do not use University resources for such communications.
- **Budget Reallocation:** Explained the process of budget reallocation, including the identification of programs with low yield and high cost, and the emphasis on general education core. Also mentioned the creation of a central pool for strategic reallocation.

• **Tenured Faculty & Program Closures:** Addressed concerns about the difficulty of firing tenured faculty and the process of program closures, emphasizing that it would be a last resort and that there would be a teach-out plan.

- 447/449 & 452 Information Security, Private Sensitive Information, and Electronic & Information Technology Accessibility (*Brett McKeachnie*) [3:38-3:42]
 - Consolidation of Policies 447 & 449 into single policy on information security to eliminate overlap and ensure comprehensive coverage of security measures.
 - Standardization of terminology across the policies to ensure consistency and clarity.
 - Updates to Policy 452 to ensure compliance with current regulations, reflecting changes in security requirements and practices.
- 616 Regular and Substantive Interaction (Laurie Sharp)

- Addresses the federal requirement for regular and substantive interaction in distance education courses to avoid being classified as correspondence courses.
- Need for a report to monitor instructor engagements in distance education courses, ensuring instructors are actively participating and engaging with students.
- 601 Classroom Instruction & Management (Kat Brown)

- Changes to accommodations for students with disabilities and religious beliefs, and guidelines for bringing minors to class.

Notes: UVU Email

UVU Policy 446 Privacy and Disclosure, Section 4.2.6: Consistent with USHE Policy 840, employees or other designated individuals who conduct university business shall use only electronic communication systems for university-related communications. Conducting university business on any personal or non-UVU enterprise email, unapproved electronic messaging or file-sharing systems, or other non-UVU electronic communication systems or methods is prohibited.

USHE Policy R840 Institutional Business Communications, Sections 4.1 and 4.2:

- 4.1 "Institutions shall establish a policy that requires its employees, officers, or other designated individuals to use only the institution's enterprise email system when conducting institutional business by email."
- 4.2 "The policy must specifically prohibit employees from using any private or non-enterprise email service for institutional email business."
