FINDING HOUSING

LOOK OUT FOR *QUEER-FRIENDLY* LISTINGS

Check out the Facebook group titled "Utah LGBTQIA+/SSA Friendly Housing". On this page you are much more likely to find listing from either LGBTQ individuals themselves, or allies.

BE TRANSPARENT

This doesn't mean you have to explicitly disclose your orientation or gender identity, but feel free to do so if you're comfortable. Instead, consider asking potential landlords or roommates directly if their place is LGBTQ-friendly or if they welcome people from diverse backgrounds and lifestyles. Transparency can help you identify and avoid

prejudiced individuals in your housing search.

TRUST YOUR GUT

Trust your instincts and walk away from any housing situation that doesn't feel right. While we may not always have the luxury of being picky, gut feelings are important. If a potential realtor, landlord, or roommate doesn't sit well with you, they're probably not the right choice. Keep looking, and hopefully, the next opportunity will be a better fit!

KNOW YOUR RIGHTS

- It is prohibited under the Fair Housing Act for any landlord or housing provider to discriminate against LGBTQ+ persons because of their real or perceived gender identity or any other reason that constitutes sex based discrimination.
- It is illegal for any landlord or housing provider to deny housing because of someone's HIV/AIDS status under the Fair Housing Act and the Americans with Disabilities Act.
- It is prohibited for a lender to deny an FHA insured mortgage to any qualified applicant based on their sexual orientation, gender identity, or marital status.
- It is prohibited for any landlord or housing provider who receives HUD or FHA funds to discriminate against a tenant on the basis of real or perceived sexual orientation, gender identity or marital status.

• It is prohibited for all homeless facilities to segregate or isolate transgender individuals solely based on their gender identity.
