**Welcome, Approval of Minutes, Administrative Updates**

- ***PACE Executive Board (Shalece Nuttall)***
  - Welcome to Vadra Rowley (sub for Jeff Anderson) and congratulations as award recipient
  - Thank you to Marissa King, who has asked to step off PACE due to other responsibilities
    - Student Affairs Senator will be re-appointed to keep on rotation
- ***Faculty Senate (Craig Thulin)***

**New Business**

- ***Proposed Executive Board Addition***

Discussed proposal to revise constitution to add an executive board member to offset increased workload. This revision expands the composition of the Executive Board to include a new Executive Vice President position, as well as revises the current title of Vice President to Administrative Vice President. The current constitution will remain in effect until these change are approved in the General Membership Meeting this June. The new position would need to be elected this year to have alternating rotation cycles to allow overlap in knowledge. The position will be included in the election with a note that it is contingent on the general membership vote. The responsibilities of the new Executive Vice President will be outlined in revised Bylaws, to be presented for approval at next month's General Board Meeting. Faculty senate gets release time, but staff do not, so it makes sense to spread the work more. The stipend would not affect the budget as the VP does not receive a stipend. The stipend is a separate issue. The President is the only one who receives a small stipend. Currently the secretary cannot receive the stipend because of non-exempt (FLMA) laws. Jennifer motioned to approve the proposed constitution changes, to add an Executive Vice President position and change the name of the current Vice President to Administrative Vice President pending the approval of the bylaws by the General board in April and pending the approval of the Constitution change in our June General Membership Meeting. The motion passed without dissent.

Total of 11% increase to base budget. Explained the new capital facilities ongoing funding model.
