- 2:15 2:25 Policy 161 Freedom of Speech (Stage 2) Ashley Larsen
 - Minimal changes to reflect current case law
 - Limited scope policy change
 - Due to case law we needed to allow an exception form to allow anonymous speech
 - Delete line to require campus entities to identify themselves
 - Campus connection will still require entities to identify but can ask for exception
 - General counsel will ensure hate speech is not posted
 - Potentially this would allow a potential for mis information to be posted Ashley will follow up
 - Clubs go through Andrea Betts office and require them to have their logo on
 - Is there a set of criteria that allows them to be anonymous not yet

 - o UVU currently uses Google Drive, Box, OneDrive, S Drive, Creative Cloud Dropbox
 - Want to reduce costs with cloud storage
 - o Failed parts of the security audit because we could not protect university data in all the systems
 - Google will no longer give unlimited access to Google storage we are 100x past the limit.
 - Have to be off by May 1
 - We will NOT lose any data
 - o Sending Dx teams to departments and colleges to do training and move the data
 - o Box raising maintenance rates by over 30% have to be off in 18 months
 - Moving to OneDrive and SharePoint
 - 1TB per person
