 - Stage 2 Shared governance model. Goes through PACE, Faculty Senate, & UVUSA
 - PACE gathers comments on policy change or add. Open 1 to 2 months
 - Ransom combines all comments
 - Survey is sent to vote by board
 - Ransom sends comments to policy steward to respond to each comment
 - Stage 3 university community can comment
 - Stage 4 President's Council then Board of Trustee review
 - Policy is finalized
 - If there is a legal reason to change policy, it does not go through all the stages
 - Additional comment we need to vote on:
 - Drug & alcohol Policy: 4.2.1 unclear if it is referring to both A & B or just B. Everyone voted in favor

 - Employees find value no matter the amount of money attached
 - Prefer more awards with less money
 - No idea what the criteria is
