# **Student Learning Outcomes**

This course is designed to achieve two main objectives. The first is to appreciate and understand the connections between firms' operation strategies and their financial statements. This understanding then serves as the basis for the second objective, which is to develop a critical, user's perspective to analyze and interpret financial statements to gain further insights into firms' performance. The course ends with a solid understanding of forecasting of financial information and firm valuation concepts and skills that can be beneficial to you for life-time.

After successful completion of the course, students should be able to:

- Have a solid understanding (including limitations) of accounting measurement and reporting for analysis purposes
- Instill an appreciation for the crucial separation of operating and nonoperating activities and their implications
- Reformulate GAAP-based financial statements for more effective financial statement analysis and valuation

- Adjust financial statement numbers for measurement limitations
- Forecast financial statements over multiple year
- Value equity securities using cash-based, earnings-based, and market-based valuation models

Both individual and team assignments are required to develop the necessary skills to achieve each of these objectives.

<u>Materials Reading</u>: You are expected to read the course materials that will be posted and discussed for each class. Those materials will be posted in Canvas weekly.

Attendance/Participation/Professionalism: This is your education, and you need to take responsibility and ownership for it. You are expected to contribute to class discussions and come prepared for the class. Attendance is mandatory. You may miss up to three classes with no negative impact to your grade. <u>MBC Quizzes</u>: There will be 10 quizzes in Canvas linked to myBusinessCourse. I will base the content of the quizzes on content from the course materials and class discussions. I will drop the one lowest quiz score. Please refer to the syllabus for the specific due dates. Quizzes are due at 11:59 pm on the date listed.

**<u>Reading Quizzes</u>**: There will be two quizzes for the article-readings assignments for the particular chapters throughout the semester. You must read the assigned materials and answer the related questions in Canvas by the due date.

**Firm Analysis & Valuation Project**: I will divide the class into groups and each group is required to complete the *Firm Analysis & Valuation Project* that requires application of the concepts/skills learned in the semester. This project is described in a separate document, so please refer to the project description handout for details. Please also refer to the *Comprehensive Case in Appendix C* (Harley-Davison Case) file as a template. Each group is required to conduct a comprehensive analysis of the company it chooses, following the Harley-Davison Case analysis format. Each group is required to write an analysis and valuation report paper and present the case analysis on the day assigned in the syllabus. Each member of the group will receive the same grade if he/she contributes equally to the work. To motivate participation of group members, you as a group are required to rate the contribution of each member and their grade is assigned accordingly. More information is in the project description.

**Examinations:** There will be two midterm exams for this class. Both exams will be given in class on paper. Both examinations are closed book. You may use a calculator during the exams. Cell phones may <u>not</u> be used as calculators.

Make-ups for exams will only be allowed if you have a University-approved excuse; and you must contact me *before* the exam is given, either by email or phone.
