**Course Assignments, Assessments, and Grading Policy**

Students will write a response to each guest lecturer. The points awarded will be based on the following criteria:

<b>Points Awarded</b>	<b>Criteria</b>
20 points	One full page of thorough, detailed notes that demonstrate what you learned related to the themes above, i.e., the lecturer's presentation, background, and what you learned that is relevant to your studies.
15 points	Not quite an entire page or not very detailed notes that don't address each of the topics above, i.e., the lecturer's presentation, background, and what you learned that is relevant to your studies.
10 points	Notes are significantly less than a full page and fail to adequately address the lecturer's presentation, background, or relevance to your studies in any significant detail.
0 points	The assignment was grossly inadequate or was not relevant to the lecture.
Late Work — 50%	Automatic half-credit reduction if the assignment was not turned in on time.

After each lecture, students will participate in a graded response to other students responses.

5 points	The student responded to the discussion prompt (2-3 paragraphs).
5 points	The student responded to at least one other peer response (1-2 paragraphs).
Late Work — 50%	Automatic half-credit reduction if the assignment was not turned in on time.

## General Description of the Subject Matter of Each Lecture or Discussion

We meet once a week for 7 weeks. Each week has a different speaker from one of the disciplines within the Department of Art & Design. (Photography, Painting/Drawing/Printmaking, Graphic Design, Illustration, Art Education, & Sculpture/Ceramics) Each area is responsible for bringing in an expert in their discipline to talk about their career in the arts. Students are required to write up their response to each speaker and then comment on other students write up.

## *Required Course Syllabus Statements*

### **Generative AI**

AI programs are not a replacement for your human creativity, originality, and critical thinking. Writing, thinking, and researching are crafts that you must develop over time to develop your own individual voice. At the same time, you should learn how to use AI and in what instances AI can be helpful to you. Due to the subject matter discussed in this course, AI will be discussed minimally but it is becoming more relevant in regards to the history of photography as a witness to history, truth, myth, & propaganda. The use of generative AI would have limited practical applications in this course but I felt it prudent to give some guidance on its uses.

The use of generative AI tools (e.g. ChatGPT, Google Bard, etc.) is permitted in this course for the following activities:

- Brainstorming and refining your ideas;
- Fine tuning your research questions;
- Finding information on the topic;

The use of generative AI tools is **NOT** permitted in this course for the following activities:

- Impersonating you in classroom contexts, such as by using the tool to compose discussion board prompts/responses assigned to you or content that you put into a Teams/Canvas chat.
- Using AI to answer questions on quizzes, tests, or in class.
- Writing your weekly responses to guest lecturers.
- Writing entire sentences, paragraphs or papers to complete class assignments.

You are responsible for the use of any information gleaned based on an AI query (for instance, that it does not violate intellectual property laws, or contain misinformation or unethical content). Any use of AI tools must be properly disclosed, documented, and cited in order to stay within university policies on academic honesty.

Any student work submitted using AI tools should clearly indicate what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, please reach out to me for a conversation before submitting your work.
