Assignment 1 – Multiple exposures - Digitally

Assignment 2 – Projections - slide projections, using photographs, or color blocks on slide film, etc.

Assignment 3 – Photo transfers

Assignment 4 – Photographing the unseen

Assignment 5 – Photographing Home

Assignment 6 – Cross pollination of the arts: Painting/ drawing/ drafting / encaustic paintings

Assignment 7 – "Shooting Through" - glass, ribbed plastic, cut gels, cut paper, fog machine, etc.

## Required Course Syllabus Statements

#### Generative AI

AI programs are not a replacement for your human creativity, originality, and critical thinking. Writing, thinking, and researching are crafts that you must develop over time to develop your own individual voice. At the same time, you should learn how to use AI and in what instances AI can be helpful to you.

The use of generative AI would have limited practical applications in this course but I felt it prudent to give some guidance on its uses.

The use of generative AI tools (e.g. ChatGPT, Google Bard, etc.) is permitted in this course for the following activities:

- Brainstorming and refining your ideas;
- Fine tuning your research questions;
- Finding information on the topic;

The use of generative AI tools is **NOT** permitted in this course for the following activities:

- Impersonating you in classroom contexts, such as by using the tool to compose discussion board prompts/responses assigned to you or content that you put into a Teams/Canvas chat.
- Using AI to answer questions on quizzes, tests, or in class.
- Creating "photographs" using an AI engine and prompts.

You are responsible for the use of any information gleaned based on an AI query (for instance, that it does not violate intellectual property laws, or contain misinformation or unethical content). Any use of AI tools must be properly disclosed, documented, and cited in order to stay within university policies on academic honesty.

Any student work submitted using AI tools should clearly indicate what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, please reach out to me for a conversation before submitting your work.
