Course Title: Interpreting I Credits: 3

Course Description

Introduces bidirectional (ASL-to-English and English-to-ASL) interpreting between Deaf and hearing people. Studies the profession and skills necessary to be an interpreter. Includes history, models, and professional certification procedures of interpreting, cognitive processes, physical and psychological factors, intercultural communication, ethics, and situational interpreting. Deaf students are encouraged to enroll. This course may be taught as an online asynchronous (no meetings) course.

In fact, I used AI to help me revise this statement. The key is to use AI to enhance your learning experience and deepen your understanding, not to bypass the effort required to grow intellectually. If you're using AI to help you learn and engage with the material—taking full advantage of your educational opportunity—you're on the right track. When you approach school as an opportunity for growth rather than an obligation to fulfill, you unlock its full potential.
