Includes commercial cross-country, instrument flying skills, and emergency procedures. Prepares students for the required FAA Commercial Pilot Airplane Practical Test. Graded credit / no-credit.

### ***Student Learning Outcomes***

- Demonstrate flight maneuvers required for complex aircraft checkout and endorsement.
  - Fly complex aircraft solo.
  - Demonstrate skills in performing steep power turn, steep spirals, and flight at minimum controllable airspeed required for commercial pilots.
  - Demonstrate skills in performing the lazy eight, pylon eight and chandelle maneuvers with precise airplane control to the required tolerances of the FAA Airman Certification Standards.
  - Demonstrate the required proficiency for a commercial pilot by extended practice in all the required commercial maneuvers.
  - Describe cross-country, instrument flying and emergency procedures required for the Commercial Pilot Practical Test.

Each student who enrolls in the Commercial ASEL Course must possess at least a third class medical certificate, a private pilot certificate with an Airplane Single-Engine Land rating, and an Instrument Airplane rating or be concurrently enrolled in the UVU Aviation Instrument Flight Course.
