#### General Description of the Subject Matter of Each Lecture or Discussion

As this is a colloquium course, each semester schedule of invited speakers will be different from week to week. Speakers who are invited to present to students come from a range of biology disciplines.

In this seminar course, you will be given a broad exposure to various work and research in biology. This course will showcase the type of presentations you would engage in at a scientific conference. At these conferences, presenters highlight their scientific work to an audience. These presentations are important in the scientific community as it allows scientists to keep up to date on the most recent research in their area. Additionally, audience members will sometimes ask questions that allow the presenter to look at their work in a new way. To ask relevant and thoughtful questions, one must learn how to actively listen to a speaker's presentation. Being able to digest information during a scientific talk, analyze that information, and create questions regarding it is an essential skill for all scientists. This course will help you learn how to actively listen during a presentation and engage with speakers in a scientific setting. Additionally, asking a question lets the speaker know who you are and that you are interested in what they are talking about. As you think towards future jobs or graduate school, these outside presenters can become key networking contacts for you.
