Course Title: Organic Chemistry Laboratory I Credits: 1

Course Description

This is the first of a series of two laboratory courses to accompany CHEM 2310 and 2320, intended for students majoring in science and those interested in careers in medicine, dentistry, veterinary science, and pharmacy. This course introduces safety in organic chemistry lab and organic chemical waste disposal. It teaches basic separatory, purification, and analytical techniques in organic chemistry such as crystallization, melting points, distillation and chromatography, introduces organic synthesis using simple organic reactions, and introduces natural product isolation.
