Every week students will apply a communication concept to their lives. Weekly assignments include research blogs, reflection journals, communication analysis, communication self-assessment. Weekly assignments will be due Sunday at midnight every week.

Class Discussions (10 pts ea.)

Each module students will answer discussion questions posted in the lecture. Please treat these seriously. This course is online so this is how we engage as if in the classroom. Discussions will be graded on thoroughness and engagement. Class discussions will be due Wednesday every week with a response by FRIDAY. I use Saturday as a grace period for students to catch up.

Generative AI

The Big AI Disclaimer

Generative AI (AI tools that can create text, images, etc.) is so new that UVU administration and faculty are still working out how these resources should and should not be used on campus. As of December 2023, there isn't an overall policy governing how and when AI tools can be used by students. Instead, you should read your course syllabi and talk to your professors about if and how AI can be used in your classes. Some professors might allow you to use AI tools in some circumstances. Some professors might ban them altogether.

AI Detection and Copyleaks

Copyleaks—UVU's new plagiarism checker—can check for text generated by AI tools. Check with your professors before you use AI tools to help complete assignments.

Plagiarism

Fabrication includes inventing quotes or information not actually in cited sources, including sources in a bibliography that you don't actually quote or paraphrase, and "[s]ubmitting as your own any academic exercises, (e.g., written work, printing, sculpture, etc.) prepared totally or in part by another" ([Your Responsibility as a Student](#)).
