<u>Application Assignments</u>: Students will complete weekly application assignments. In these assignments, students will apply the concepts and theories they learned that week in class. To complete these assignments, students will need to be familiar with the weekly reading. On average, application assignments can be completed in 1-3 hours. In these assignments students will be evaluated on their familiarity of course concepts, idea development, and writing conventions.

<u>Discussions</u>: Students will participate in weekly discussions. Discussions will ask students to reflect on and practice material from that week's reading and lecture. In discussions, students will be evaluated on their idea development and writing conventions.

Quizzes: Students will complete weekly quizzes the cover material from the required reading. Research Assignments: Throughout the semester students will complete 5 core research assignments. These assignments are the building blocks to the final proposal in the course due at the end of the semester. All research assignments must be completed to pass this class. If one of the following research assignments is not completed, regardless of the total grade in the class, the student will not earn a passing grade.
