## Course Description

Focuses on development of solid foundational skills in modern dance technique and theory that prepare the student for an intensive major program. Emphasizes the development of strength, flexibility, core support, coordination, kinesthetic awareness, memory, and movement expressiveness. Includes experience in improvisation and composition as a means of understanding and applying technical skills in performance settings. May be repeated for a total of six credits towards graduation.

## Student Learning Outcomes

- 1. Manifest increased body connectivity that provides clear connection between core and distal edges.
- 2. Perform increasingly complex level 1 movement combinations with efficiency, clarity, and consistency.
- 3. Participate in daily class by taking personal responsibility for full presence and commitment.
- 4. Demonstrate increased basic level of core support and dynamic alignment.
- 5. Identify the elements of dance through movement with consistency.
- 6. Develop skills in self and peer observation.

Proper dance attire is required for this course. Students may also need a recording device (phone or camera) for course evaluations.

## Course Requirements

### Course Assignments, Assessments, and Grading Policy

- **Skill:** Level I develops technical ability and awareness of movement principles. Students will be graded on their progress and growth in regard to the following: the ability to pick up and remember movement material, differentiation of rhythmic phrasing, an embodied understanding of neuromuscular patterning, attention to alignment and core support, increased spatial awareness, qualitative changes in movement, and the ability to implement feedback. Active participation, consistent attendance, and incorporation of peer and instructor feedback will facilitate improvement and success. (60% of overall grade)
- Participation: All course concepts are presented through various modes such as demonstration, repetition, description, discussion, consensual touch, journaling, writings etc. Students are required to participate to their full ability. Physical exploration including improvisation and composition, critical observation, and verbal participation are the primary means of learning. Integration and embodiment of lessons and corrections develop artistry. (25% of overall grade)
- Concert Attendance: Attending live dance performances can deepen our understanding of artistry while simultaneously demonstrating support for the artform and extending our professional networks. (5% of overall grade)
- Midterm: At the midterm time, the student and instructor(s) will assess technical and artistic progress in the class. Specific details and requirements regarding video days, self-reflections, and conferences, if applicable, for the assessment will be discussed. (5% of overall grade)
- **Final:** At the final time, the student and instructor(s) will assess technical and artistic progress in the class. Specific details and requirements regarding video days, self-reflections, and conferences, if applicable, for the assessment will be discussed. (5% of overall grade)

This course teaches body and performance techniques, dynamic alignment, weight shift, rotary function, foot articulation, axial and locomotor skills, total body connectivity, and floorwork, among other concepts. Classes are specifically designed to meet the skill level of the students in the class who work on foundational concepts through improvisation, phrasework, composition, and performance.

#### Generative AI

- Completing group work that your group has assigned to you, unless it is mutually agreed upon that you may utilize the tool.
- Writing a draft of a writing assignment.
- Writing entire sentences, paragraphs or papers to complete class assignments.

You are responsible for the information you submit based on an AI query (for instance, that it does not violate intellectual property laws, or contain misinformation or unethical content). Your use of AI tools must be properly documented and cited in order to stay within university policies on academic honesty.

Any student work submitted using AI tools should clearly indicate what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, please reach out to me for a conversation before submitting your work.
