## ***Course Requirements***

### **Course Assignments, Assessments, and Grading Policy**

#### **EXAMS**

- Students are required to take practical exams on each dance, physically demonstrating the material.
- Students are required to take the final exam. The final exam will be comprehensive and practical. A medals exam score can be used as a replacement for your final.
- The final will be held on the last day of regular class (Dec 6)

#### **DANCE LAB PARTICIPATION**

- Students are required to attend and participate in the dance lab and remain through the entire scheduled time. (Tues, Nov 12)

#### **DANCESPORT FESTIVAL PARTICIPATION**

- Students will attend and compete at the UVU Dancesport Festival. If the ratio between leads and follows does not allow for all class members to have a partner, those students who do not have a partner will still be required to attend the event, however a response paper on the Dancesport Festival will be required in place of the competition requirement. This only will be allowed if all partners have been taken. You may also dance with a partner that is in a lower-level technique class or one that has taken this class previously but has not taken a higher-level class in this style.
- Your student fees cover the registration portion of the event, however you will be required to purchase an entrance ticket for each day you attend the event.

#### **CONCERT OBSERVATION PAPER**

- Students will attend the UVU Ballroom Dance Company Concert.
- A paper on the concert will be required, comparing and contrasting several different styles.

- The paper will be at least two pages, double-spaced in 12-point font, regular margins, with MLA format.
- Students must purchase an admission ticket to attend this event.

### **General Description of the Subject Matter of Each Lecture or Discussion**

For each dance:

- Correct rhythm, poise, footwork, foot position, body alignments, and dance position.
- Identify leading and following principles.
- Understanding of the differences in the amounts of rise and fall of the different dances.
- Proper body flight.
- Floor craft.
- Knowledge of steps, including correct names.
- Understanding of the different areas of ballroom dance: social, competition, and performance.

#### **Generative AI**

- Writing a draft of a writing assignment.
- Writing entire sentences, paragraphs or papers to complete class assignments.

You are responsible for the information you submit based on an AI query (for instance, that it does not violate intellectual property laws, or contain misinformation or unethical content). Your use of AI tools must be properly documented and cited in order to stay within university policies on academic honesty.

Any student work submitted using AI tools should clearly indicate what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, please reach out to me for a conversation before submitting your work.
