Course Title: Choreography Credits: 2

Course Description

The course provides an in-depth experience in the choreographic process. Focuses on development of personal voice in choreography and the ability to generate choreographic form intrinsic to thematic content. Explores the use of choreographic forms and devices as means of developing thematic content. Requires intensive exploration of the creative process through imaginative thinking, creating, and crafting in movement.

Choreographic Work

- 3. **Ensemble Choreography** (10%) The final showing must demonstrate the completion of a dance, along with defined production elements (working title, proposed lighting, set designs, music, and costumes). See accompanying written assignments below.
- 4. Final Choreographic Work (10%)

Written Assignments

- 1. Intro Assignment (5%)
- 2. **Talking Points** (15%) a written reflection on reading and viewing assignments throughout the semester.
- 3. Ensemble: Contextual Research Analysis Paper with Works Cited (10%) an analysis of the research you have conducted pertaining to the content, choreographic process, and intent of your work
- 4. Ensemble: Abstract (5%) a concise description of the choreographic work
- 5. Choreographic/Process Assessments (15%) written reflection of self-assessment
 - 1. Choreographic Process Reflection 1 (solo)
 - 2. Choreographic Process Reflection 2 (duet/trio)
 - 3. Choreographic Process Reflection 3 (ensemble)
- 6. **Final:** Choreography Project (15%) A written proposal of the student's choreographic project, including an Abstract and Prospectus (Introduction, Motivation, Intent, Contextual Research, Process, etc.)

Generative AI

- Brainstorming and refining your ideas;
- Fine tuning your research questions;
- Finding information on your topic;
- Drafting an outline to organize your thoughts; and
- Checking grammar and style.

The use of generative AI tools is not permitted in this course for the following activities:

- Impersonating you in classroom contexts, such as by using the tool to compose discussion board prompts/responses assigned to you or content that you put into a Teams/Canvas chat.
- Completing group work that your group has assigned to you, unless it is mutually agreed upon that you may utilize the tool.
- Writing a draft of a writing assignment.
- Writing entire sentences, paragraphs or papers to complete class assignments.

You are responsible for the information you submit based on an AI query (for instance, that it does not violate intellectual property laws, or contain misinformation or unethical content). Your use of AI tools must be properly documented and cited in order to stay within university policies on academic honesty.

Any student work submitted using AI tools should clearly indicate what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, please reach out to me for a conversation before submitting your work.
