Technique and Theory III/Semester II

Course Description

Builds technical, performance and theoretical understanding and skills in modern/contemporary dance. Expands on the skills and concepts introduced in DANC 3410R. Emphasizes body and performance techniques, axial and locomotor skills, total body connectivity movement progressions; increased spatial, rhythmical, and qualitative acuity; risk-taking; and movement commitment. Includes aspects of composition, improvisation, and performance as they relate to technique. May be repeated for up to 9 credits total toward graduation.

Skill (70%):

Level III integrates technical skills with refined performance quality. Advanced skill is evident in the ability to pick up and remember movement material, clarity of rhythmic phrasing, clear neuromuscular patterning, alignment, core support, spatial awareness, attention to detail and quality of movement, physical and technical proficiency, ability to implement feedback, and development of personal artistry in performance. Active participation, consistent attendance, and incorporation of peer and instructor feedback will facilitate improvement and success in developing advanced contemporary/modern dance skills.

Participation (15%):

The Participation portion of your grade considers how you engage in class on a daily basis. How you take class influences not only your own learning but also influences the learning environment of the class and the learning of others.

Concert Attendance (5%):

Attending live dance performances can deepen our understanding of artistry while simultaneously demonstrating support for the artform and extending our professional networks. You are required to attend two pre-professional/professional concerts.

Assessments (10%):

Midway through the term and at the final time, the student and instructor(s) will assess technical and artistic progress in the class. Specific details and requirements regarding video days, self-reflections, and conferences for the assessment will be discussed.

General Description of the Subject Matter of Each Lecture or Discussion

The course teaches body and performance techniques, dynamic alignment, weight shift, rotary function, foot articulation, axial and locomotor skills, total body connectivity movement progressions; spatial, rhythmical, and qualitative acuity; risk-taking; and movement commitment. The course includes aspects of composition, improvisation, and performance as they relate to technique.

The subject matter above is taught in a holistic and comprehensive manner over the course of the semester and responds to the learning needs of the individual students in the class.

Module 1: Dynamic Alignment and Grounding: finding connectivity for functional and efficient alignment and support

Module 2: Weight Shift: focuses on bony landmarks and locomotor movements

Module 3: Shape: finding fluidity of the torso, including breath support and axial movement

Module 4: Effort: focuses on rhythmic clarity and qualitative nuance as related to performance and artistry

Module 5: Space: finding clarity of dimensions, planes, and diagonals to support expressive movement and negotiation complex spatial facings

Your use of AI tools must be properly documented and cited in order to stay within university policies on academic honesty. Any student work submitted using AI tools should clearly indicate what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, please reach out to me for a conversation before submitting your work.
