Student Learning Outcomes

- 1 Create a substantial piece of choreography for performance, including directing rehearsals and coaching performance quality in dancers.
- 2 Organize and conduct auditions and choreographic showings.
- 3 Present an artistic choreographic work with clear intent, observable use of movement invention, skillful rendering of the elements of dance, and adept use of formal choreographic principles and choreographic structures.
- 4 Organize a dance concert, including processes of designing, marketing, producing, and directing.
- 5 Assimilate feedback on choreography and performances.
- 6 Create discipline-specific text that analyzes and synthesizes essential elements of choreography and concert production.

Course Requirements

Course Assignments, Assessments, and Grading Policy

Grading:

Class Participation 10%

This portion of the grade reflects the student's level of interaction during auditions, class discussions, photo shoots, choreographic showings, and concert week rehearsals and activities.

Production work: 15%

On the first day of class, students will organize Production committees that will carry out all tasks and activities necessary to design, market and produce a formal dance concert.

Original Choreography/Performance/Project: 45%

Choreography Track-

The creation of unique choreography that demonstrates the choreographer's personal choreographic voice carries the greatest weight of the final grade. It includes the following:

Performance Track-

The performance in original choreography that demonstrates the performer's unique artistic voice and detailed work as a rehearsal assistant carries the greatest weight of the final grade. It includes the following:

Independent Project Track-

The creation of a fully produced concert that demonstrates the creator's personal choreographic voice and artistic direction carries the greatest weight of the final grade. It includes the following:

Written Work: 30%

As part of the artistic process students will submit well-written and clearly articulated proposals and statements.

- Final Prospectus/Rehearsal Plan (Choreographers)
- Artist Statement
- Analysis of Choreographic Feedback

Generative AI

AI programs are not a replacement for your human creativity, originality, and critical thinking. Writing, thinking, and researching are crafts that you must develop over time to develop your own individual voice. At the same time, you should learn how to use AI and in what instances AI can be helpful to you.

The use of generative AI tools (e.g. ChatGPT, Google Bard, etc.) is permitted in this course for the following activities:

- Brainstorming and refining your ideas;
- Fine tuning your research questions;

- Finding information on your topic;
- Drafting an outline to organize your thoughts; and
- Checking grammar and style.

The use of generative AI tools is not permitted in this course for the following activities:

- Impersonating you in classroom contexts, such as by using the tool to compose discussion board prompts/responses assigned to you or content that you put into a Teams/Canvas chat.
- Completing group work that your group has assigned to you, unless it is mutually agreed upon that you may utilize the tool.
- Writing a draft of a writing assignment.
- Writing entire sentences, paragraphs or papers to complete class assignments.

You are responsible for the information you submit based on an AI query (for instance, that it does not violate intellectual property laws, or contain misinformation or unethical content). Your use of AI tools must be properly documented and cited in order to stay within university policies on academic honesty.

Any student work submitted using AI tools should clearly indicate what work is the student's work and what part is generated by the AI. In such cases, no more than 25% of the student work should be generated by AI. If any part of this is confusing or uncertain, please reach out to me for a conversation before submitting your work.
