### ***Course Description***

*Prerequisites:* Portfolio review and acceptance, or instructor approval in special cases. Completion of foundational audio courses is expected.

This course provides an in-depth exploration of audio mastering, the final stage of the audio production process. Unlike production and mixing, mastering requires an objective approach to enhance the sound quality and prepare audio for distribution. Key topics include:

- Understanding the objective standards for high-quality mastering.
  - Exploring the roles of the Mixing Engineer, Mastering Engineer, and Aggregator (digital distribution house).
  - Developing critical listening habits for evaluating and improving audio quality.
