Course Title: *Performance Animation*

Credits: 3

Course Description

This course focuses on advanced techniques in performance animation, combining acting principles, motion capture, and technical workflows to create compelling animated performances. Students will learn to direct and animate characters in dynamic and emotional scenes, utilizing industry-standard tools and technologies to develop skills applicable to animation and game production pipelines.

Course Requirements

Assignments, Assessments, and Grading Policy

- Acting Exercises:** Weekly exercises focusing on character performance through acting and animation principles (20%).

- **Motion Capture Assignments:** Recording and refining motion capture data (30%).
- **Scene Development:** Creation of animated scenes showcasing emotional and dynamic performances (30%).
- **Final Project:** A polished performance animation integrating all techniques learned in the course (20%).

Late Policy

- Assignments are subject to a 10% late penalty per day, with a cut-off at one week after the due date.

General Description of the Subject Matter of Each Week

Weeks 1-2: Foundations of Performance Animation

- Week 1: Acting for animators – principles of movement and expression.
- Week 2: Introduction to motion capture systems and workflows.

Weeks 3-6: Motion Capture and Data Processing

- Week 3: Recording motion capture data – capturing emotional performances.
- Week 4: Cleaning and refining motion capture data.
- Week 5: Combining motion capture and keyframe animation techniques.
- Week 6: Milestone 1: Submit a short performance animation clip using motion capture.

Weeks 7-10: Directing Animated Performances

- Week 7: Storytelling through performance – directing characters in scenes.
- Week 8: Animating dialogue and body language.
- Week 9: Iterating on performances based on feedback.
- Week 10: Milestone 2: Submit a complete scene with animated performances.

Weeks 11-14: Finalization and Presentation

- Week 11: Refining animation – polishing and adding nuance to performances.
- Week 12: Preparing final animations for presentation.
- Week 13: Submission of final project for review.
- Week 14: Final presentations and course wrap-up.

Weekly Deliverables

- **Acting Exercises:** Videos, sketches, or animation tests based on acting principles.
- **Motion Capture Deliverables:** Cleaned and processed motion capture data.
- **Scene Deliverables:** Drafts and iterations of performance animation scenes.
- **Final Project:** A polished animated scene or sequence showcasing character performance.
