The course consists of individual clinical work, documentation and reporting of growth in the seven state leadership standard areas. Students meet with faculty on an individual basis to review progress and report their work.

The use of generative AI tools is not permitted in this course for the following activities:

- Impersonating you in classroom contexts.
- Writing a draft of a writing assignment.
- Writing entire sentences, paragraphs or papers to complete class assignments.

You are responsible for the information you submit based on an AI query (for instance, that it does not violate intellectual property laws, or contain misinformation or unethical content). Your use of AI tools must be properly documented and cited in order to stay within university policies on academic honesty. Any student work submitted using AI tools should clearly indicate what work is the student's work and what part is generated by the AI.
