ENGL 2010 emphasizes academic inquiry and research in the humanities and social sciences. ENGL 2010 explores issues from multiple perspectives and teaches careful reasoning, argumentation, and rhetorical awareness of purpose, audience, and genre. ENGL 2010 focuses on critically evaluating, effectively integrating, and properly documenting sources. In addition to major essay assignments, the course includes online writing and collaboration, an annotated bibliography, oral presentations, and a final project.

Generative AI



The UVU English department is also keeping up with generative AI such as **ChatGPT.** Believing the technology is here to stay, and will only grow, we feel it's important to understand both its strengths and limitations. AI is fraught with serious issues. It possesses accuracy problems while simultaneously sounding very confident about its incorrectness. It also frequently generates fake citations and quotations. It cannot understand the complexities and contexts of human communication. To be clear, using AI to brainstorm, draft, revise, or copying the exact wording of an AI chatbot, is considered plagiarism and means that a student will be held accountable for violating academic integrity.
