Course Requirements

Course Assignments, Assessments, and Grading Policy

Attendance: For students to obtain a recommendation for certification, a student can not miss more than 6 class periods (including partially missed days)

Assignments: There will be multiple assignments given throughout the semester. Refer to Canvas for assignments and due dates.

Testing: Students will be expected to complete tests and quizzes assigned in the weekly modules. Students will also be expected to complete Platinum exams, final exams and other quizzes and tests assigned throughout the class. Please refer to the course schedule and Canvas for specific dates.

Platinum: There will be 6 Platinum tests throughout the semester, please refer to the course schedule for the specific testing dates. You will have **2 attempts at taking each exam**. To be eligible to retake the exam a second time you MUST have your prescription for that exam submitted. If you chose NOT to retake a unit exam you still MUST submit a prescription for the exam.

Finals: Students will be assigned a comprehensive class final and a comprehensive Platinum Final. Students will have **1 attempt for each final**. Refer to Canvas and the course schedule for final test dates.

Recommendation eligibility

For students to be recommended to the Utah Bureau of EMS for licensure and National Registry certification ALL of the following requirements MUST be met:

- 1. Overall class average must be 80% or higher.
- 2. All prescriptions must be turned in and acceptable.
- 3. Average of 75% or higher on Platinum Exams.
- 4. A score of 75% or higher on both comprehensive finals.
- 5. Meet Affective Behavior evaluation criteria.
- 6. Meet the attendance requirement.
- 7. Submit completed skills sheet.
- 8. Successfully pass a final medical patient assessment and a final trauma patient assessment.

National Registry Testing

Becoming a Nationally Registered EMT is broken down into two parts, <u>practical</u> and <u>cognitive</u> (Written).

PART I – National Registry PRACTICAL testing will take place the last week of the course (please see course schedule for specific dates).

PART II – National Registry COGNITVE (Written) testing is taken after the course is completed.

Prior to receiving permission to test, you will need to complete the following requirements:

- All course requirements (see Recommendation Eligibility)
- Receive approval from program coordinator
- Be recommended by Utah BEMS to Nationally Test

You will need to schedule the cognitive test online at nremt.org. You will have 3 attempts to pass the NREMT test. A fee of \$104 per attempt must be paid before you can schedule a test. The fee for your first attempt should have been paid during the initial application process at the beginning of class. If the student does not pass the NREMT test in 3 attempts, the student will have to go through remediation. After completing remediation, the student will have an additional 3 attempts to pass the NREMT test. Testing fees and remediation, if necessary, are the student's responsibility.

- 2. Students will have 2 attempts at each Platinum Exam, other than the final. The second attempt will only be allowed after the prescription for the exam has been submitted.
- 3. Assignments include reading, pretest, homework, and posttest for **every** chapter. There may be additional assignments for specific chapters and topics.
- 4. No incompletes are allowed for the course.
- 5. Testing material covers all lectures, handouts, reading materials, and practical skills.
- 6. Consult your course schedule and Canvas modules for assignments and due dates.
