Course Assignments, Assessments, and Grading Policy

- Writing assignments: Weekly writing assignments related to the weekly lecture/discussion. Eash writing assignments is one page in length APA format. Student must attend live sessions to receive credit for the weekly writing assignment. (90% of overall grade)
