Course Title: Production Practicum Credits: 1

## Course Description

Provides opportunity for earning college credit for supervised performance and production assignments in UVU theatre productions from dress rehearsal through closing performance (excluding strike). Allows students to apply learned skills to productions that are currently in performance. Requires project approval from instructor or Department Chair. May be repeated for a maximum of 8 credits toward graduation.

# **Assignment and Assessment Descriptions**

### **CLASS ACTIVITIES:**

- 1. Attendance is mandatory and promptness is required. A sign-up sheet will be posted in the rehearsal and performance spaces and students will initial by their name when they arrive. Any pre-approved absences or conflicts will not be counted against the attendance grade. To receive 100% of your attendance points you must not miss ANY rehearsal for which you are not excused ahead of time. If you are too ill to participate, but not bed ridden or contagious, attendance (in a mask if appropriate) is encouraged. Observing rehearsal is better than missing. Sign-in sheets will also be posted during the run of the show.
- 2. Participate in discussions, warm-ups, & rehearsals.
- 3. Rehearse & perform material from selected musical.
- 4. Be prompt, prepared and ready to work each rehearsal.
- 5. Complete memorization by the designated dates (listed in the course calendar).
- 6. Perform the entire run of the production.

# **Grading**

## The following will be used to determine the grade for production:

1. **Attendance:** (this includes costume fittings, costume parade, makeup tutorials, publicity photos, etc.) 100 points

- 2. **Memorization:** Off-book on time, with accuracy. A percentage will be given based on how each actor performs on the designated "off-book" day. This includes choreography, lines, and lyrics/notes. All production staff (director, music director and choreographer) will determine this grade together. Please note that there are 4 separate off book dates. Two are for vocal memorization, one for Act I and one for Act II, and two are for lines and choreography, one for Act I and one for Act II. 50 points per off-book day, 200 points total.
- 3. **Citizenship\*\*:** Respect to fellow actors, crew, designers, and any other artistic staff. Respect to microphones, hanging up costumes, keeping your dressing room clean, returning your rented libretto/score on time and clean, etc. 200 points

\*\*Students who arrive on time to every rehearsal, memorize their lines in the provided time frame, demonstrate respect for artistic staff and other actors, and dedicate themselves to the success of the production will receive an "A." A student who demonstrates deficiency in any of the above areas will be graded accordingly. It is always the goal of the performing arts faculty to achieve a professional, educational, safe, and healthy working environment. Please do all you can to contribute to this effort.

- Writing a draft of a writing assignment.
- Writing entire sentences, paragraphs or papers to complete class assignments.

You are responsible for the information you submit based on an AI query (for instance, that it does not violate intellectual property laws or contain misinformation or unethical content).
