### **JOB DESCRIPTION SUMMARY:**

Under the direction and guidance of the Wildland Division Chief, the Seasonal Firefighter is a Wildland crew member serving under an Engine Boss. The seasonal firefighter will perform in all aspects of wildland firefighting to include preparedness, fire suppression, and mop up. The seasonal firefighter is expected to assist the Department in filling resource orders during the Wildfire season. They are required to be ready and available for all deployments. They should expect to travel 50% of the time and must be available to respond as needed for incidents up to 21 days. When not on detail, the Seasonal Firefighter will be assigned duties at the station as well as assist locally with fuels mitigation and other projects.

The position is non-benefited and full time, seasonal from April 1 through October 31. The position has assigned shifts and is compensated for overtime on resource order deployments. The seasonal firefighter is expected to participate in training and career development.

While this position has Wildland assignments, it is an integral part within Moab Valley Fire Protection District and is part of the larger team. The Seasonal Firefighter is expected to meet all requirements of maintaining membership in the Department. When in District and available, this position will respond to calls to service for the Department.

The Seasonal Firefighter responsibilities may involve performing hazardous tasks requiring strenuous physical exertion for extended periods of time in cramped surroundings, hot, smoky environments with limited visibility, and at considerable heights.

### **BASIC REQUIREMENTS:**

The following certification is required and must stay current. New hires without the certification will be required to be certified within 1 month of hire :

- WL FF II

Other requirements:

- Must be at least 18 years of age
- Must possess a valid drivers license

### **CONTINUOUSLY PARTICIPATES IN ONGOING TRAINING:**

Complete training as required to meet Fire, State and federally recognized and accepted standards, which may include classroom and practical instruction as well as hands-on evaluations, examinations, and certification in a variety of areas. Training includes both structural and Wildland aspects of firefighting. The Seasonal Firefighter must remain current on Fire service principles and practices. The seasonal firefighter is expected to participate in a daily physical training program.

### **ACTIVELY PARTICIPATES IN FIRE PREVENTION/PREPAREDNESS / PUBLIC EDUCATION / PUBLIC RELATIONS ACTIVITIES:**

Follow District policies and procedures and project a professional public image.  
Participate in Department activities to educate the public on fire prevention and preparedness.
