On the fourth day, which was the last day for me in the United Nations (UN) and New York City, at 8:30AM we attended a briefing by the NGO CSW/NY which took place at the UN Headquarters. At the briefing, leaders from UN Women and NGO CW/NY spoke to the audience of civil society leaders about the negotiations surrounding the final draft of the 63rd Commission on the Status of Women (CSW63) final document in the UN. They started the panel with a background about what was going on during the entire week and how things are going. After that, a question and answer session was conducted, where our mentor Dr. Abdrisaev made his comments about the necessities of including the mountain women and girls in the finale document. Dr. Abdrisaev explained how those women are suffering and in need for the member state negotiators to include them in the final document. However, the answer to Dr. Abdrisaev was that those minorities need to push harder. But after that, my colleague Mr. Michael Hinatsu ask a question and made

a comment about the mountain women and how they are suffering for being women in the first place and being in such a high altitude where the sources of empowerment and sustainable development are difficult to get to their environments. The co-host of the briefing agreed with him but they still recommended for a higher number of countries with mountain women involved in UN activities. However, by the end of the panel, an African-American lady named Queen Mother Dr. Delois Blakely said that they will go to the United States Congress on Thursday to push the U.S Congress more to support women rights and equality and correct the current situation when many women were denied visa to come to CSW63.

goodbye to Ambassador Atayeva. However, it was a great experience for me to meet and speak to such a high-level diplomat who has served her country for 24 years as a Permanent Representative (PR) for Turkmenistan to the United Nations and now is the Dean of all PRs accredited at the UN.
